Animal Communication Agreement

By confirming and accepting your appointment with Reisa you understand and accept the following:

Reisa Stone is an Animal Communicator. She does not represent herself as giving veterinary, medical, financial or psychotherapeutic advice. Animal Communication is meant to foster understanding and harmony between human and animal. Reisa does not guarantee nor take responsibility for the outcome of the session. The client is 100% responsible for any action taken based on interpretation of the insights in a session. The session fee is paid for the output of time and energy Reisa expends on your behalf.

This session is one on one. Third parties on extensions, speakerphones, etc., must be pre-approved to participate. Unapproved third parties can interfere with pets' willingness to communicate and thus degrade the value of your session.

It is not ethical for Reisa to communicate with animals belonging to third parties, such as roommates, neighbours or ex-partners. Shelter/rescue/foster animals are fine, as are wildlife.

It is understood that positive change cannot occur without effort. Animals need veterinary care, training, good nutrition and a consistent routine. Perceived misbehaviours may sometimes be our pet educating us as to our own issues. If a guardian chooses not to act on their issues, positive change with the pet may not take place.

I further agree to the following:

- a. If I need to reschedule my appointment, I am required to give Reisa Stone a minimum 24 hours notice.
- b. If I miss my appointment, without giving Reisa 24 hours notice for rescheduling, I will be charged the full session fee. I understand my session time is according to *Pacific Standard Time*. This is Vancouver, BC Canada on the World Clock. If I call in more than fifteen minutes late for my session, it will be cancelled without refund.
- c. If in British Columbia Canada, I am nineteen (19) years of age or older, of sound mind, and not under the influence of mind altering drugs. If I am in another province, state, or country, I am of legal age to enter into an agreement.
- d. If I give permission for my session to go over the allotted time, I will be billed for the additional time. This extra time will be prorated at the current session rate.

I acknowledge that I have read the above, have thoroughly reviewed and understand its contents, and that I am giving my informed consent and it is my intent to agree to this contract. This contract is governed by the laws of the province of BC, Canada. By confirming my appointment I release Reisa Stone from any and all legal responsibility.
